With reference to the queries received regarding the above-mentioned EOI, the following clarifications are issued:

Sr. No.	Query	MITL Clarification
1	Availability of detailed EOI document, formats, evaluation criteria, scoring methodology and draft terms of engagement	The published EOI constitutes the complete EOI document. Application format is enclosed as Annexure B. Applicants may submit their credentials and relevant information as specified in the EOI & Annexure B.
2	Whether MITL intends to empanel one or multiple law firms	MITL intends to empanel multiple Law firms.
3	Retainership or case-wise engagement model	MITL intends to follow case wise engagement model.
4	Fee structure and reimbursement of expenses	Professional fees and reimbursement of expenses, wherever applicable, shall be mutually agreed upon by MITL and the selected advocate/law firm at the time of assignment.
5	Meaning of five years of standing for law firms	The minimum standing of five years shall be reckoned from the date of registration with Bar Council.
6	Definition of dedicated practice group	The requirement is intended to ensure demonstrable experience and capability in energy, infrastructure, regulatory affairs or corporate dispute resolution matters. Applicants may provide relevant details of their practice, team composition and experience for MITL's consideration. Preference will be given to Electrical Distribution Licensee Business.

7	Minimum number of partners/advocates	No minimum number of partners or advocates has been prescribed under the EOI. However, it is expected that applicant can provide these details to demonstrate adequate professional and infrastructural capacity to undertake assignments covered under the scope of work.
8	Requirement of prior empanelment with Government/PSU/Regulatory Authority	Prior experience in handling legal matters of Government organizations, PSUs or regulatory authorities is mandatory eligibility criterion under the EOI. Such experience, be included in the application format submitted by the applicant.
9	Whether there will be RFP/financial bid stage after EOI	The present process is limited to empanelment through EOI. MITL reserves the right to adopt any further selection process, if necessary.
10	Annual performance evaluation, termination and renewal	The empanelment shall remain valid for three years subject to annual performance evaluation by MITL. The methodology and parameters of evaluation, continuation, discontinuation, renewal or termination shall be determined by MITL and its decision shall be final.
11	Publication of responses and extension of submission date	These clarifications shall form part of the EOI. Any amendment, corrigendum or extension of timelines, if considered necessary, shall be published by MITL through appropriate means, on its website www.auric.city .
12	List of power sector clients represented	No minimum number of power sector clients has been prescribed. Applicants may furnish details of relevant clients and assignments to the extent permissible under applicable professional obligations and confidentiality requirements.
13	Checklist of documents required	Applicants should submit their detailed profile along with supporting documents demonstrating eligibility, experience, credentials, organizational details and statutory registrations as considered relevant by the applicant. Please refer Annexure B.

14	Prescribed application format	Applicants are requested to submit their applications in the prescribed format attached as Annexure B, ensuring that all information sought in the EOI is duly provided. Kindly refer to Annexure B for the detailed application format and requirements.
